General Liability Waiver and Release

With full knowledge of these risks, I hereby waive, release, discharge, and hold harmless the Southwest Sniffers Scent Work Club of New Mexico, its officers, directors, members, volunteers, agents, and event hosts or venue owners from any and all claims, causes of action, demands, or liabilities of any kind arising out of or connected with my participation in or attendance at any Club-sponsored activity or event. This includes, without limitation, any injury, damage, or loss caused by any dog (including my own), person, or condition of the premises.
